Explanation of Responses:

1. This transaction involved a cash exercise of stock options.

2. The shares were sold in multiple transactions at prices ranging from \$40.00 to \$40.25, inclusive. This amount represents the weighted average sale price of such transactions. 3. Reflects options to purchase a total of 4,200 shares of common stock granted to Ms. Tsuchimoto on April 4, 2016, for her services as a director and prior officer of Monopar Therapeutics. The options vested 6/12ths upon the grant date and 3/12th every 6 months thereafter.

4. Reflects options to purchase a total of 4,704 shares of common stock granted to Ms. Tsuchimoto on February 20, 2017, for her services as a director and prior officer of Monopar Therapeutics. The options vested 6/48ths upon the 6-month anniversary of the grant date and 1/48th per month thereafter.
